The Medcor onsite clinic offers a variety of essential services to Montana Renewables employees.

Background

Montana Renewables, LLC is a renewable fuel business headquartered in Great Falls, Montana. They process up to 15,000 barrels per stream day of renewable feedstocks — seed oils, used cooking oil and tallow into low-emission sustainable alternatives that directly replace fossil fuel products.

They can have from 200 to 300 employees onsite each day during a non-outage season, and up to 500 to 600 daily during outage season.

Situation

Montana Renewables already worked with Medcor via an agreement with another provider. When that provider's contract ended in 2021, the client engaged Medcor exclusively to provide onsite clinics, telehealth services, 24/7 injury and illness triage and a variety of other related services.

The wide range of needs at this client's site, as well as its variable staffing levels, meant they needed an occupational health and safety provider that could be flexible with the services offered and scale their offerings up or down based on the client's busy seasons.



Solution

Medcor operates one full-time onsite clinic at Montana Renewables. During the non-outage season, the clinic operates Monday through Friday, 8 a.m. to 5 p.m., and is staffed by one full-time occupational health technician (OHT). For injuries and illnesses that occur during times when the clinic is not open, the clients can utilize Medcor's injury and illness triage service to help evaluate the type of care their injuries require. In outage season, the clinic shifts to being open 24 hours a day, seven days a week, and an additional OHT joins the operation.

The onsite clinic offers a variety of essential services to Montana Renewables employees. In addition to skilled care for work-related injuries and illnesses, the client receives onsite drug testing services, emergency response training, case management services, OSHA reporting, CPR and safety training and confined entry training. These valuable offerings help keep workers at Montana Renewables safe and high performing, even when they are working long hours.
